The Feasibility stage is crucial for determining whether the project is not only viable but also worth the investment, as well as setting a baseline for all measurements throughout the execution and post-opening phases of your business.

A strong feasibility study should detail the justification of your concept, profit channels, execution plan, brand positioning, and company description. The monetary part of the feasibility study should outline your capital budget, including rent, equipment, professional services, and other relevant expenses. The study should list the sales projection, staff hierarchy, P and L calculations and lastly your break-even calculations.



A strong feasibility study is a highly detailed justification of the concept, which is the first step to determining the rest of the feasibility. Once your concept has been developed, you can determine the profit channels that need to be covered by determining the target and location of the proposed outlet. An execution plan is developed to create a strong brand positioning and company description.



The majority of the feasibility is compiled by conducting careful research, analysis, industry percentages, and reports from government agencies to determine averages and projections for your concept. A good feasibility study lists your capital budget, including rent, equipment, professional services, etc., as well as listing the sales projection, staff hierarchy, P and L calculations, and lastly your break-even calculations.





A crucial section of the study is to determine potential revenue, you can project your operating hours, seating or take-out capacity, and revenue per customer goals that are a reflection of the market size. Use this data to complete an hourly based Revenue Per Available Seat Hour analysis to back-up your numbers and realistically see how many customers can be served per hour, day, week, and month.
